General

We are only able to offer the Summer School-Course under the following conditions. The applicable law is German Law. Place of jurisdiction is Villingen-Schwenningen/Germany.

Sign Up

You can apply for the course online. The deadline for registration, the registration fees, the services, payment terms and conditions for participation can be found in these General Conditions and in the relevant course information on this homepage.

Limited number of participants

For didactic reasons we have chosen a maximum number of participants of 12 in the course. Registrations of suitable applicants will be accepted in order of receipt and payment. Therefore early registration for the course is recommended.

Terms of payment

Our course is free of VAT. Please pay the course fee in full within 10 days after receipt of electronical pdf-invoice, latest to the 15th June 2018.

Cancellation policy

If you are unable to attend the course, you must submit a withdrawal notice in writing by email (hor@hs-furtwangen.de), fax or post.

- Cancellations will be refunded as follows: Withdrawal submitted by 22th April 2018: 95% tuition refund
- Withdrawal submitted by 15th May 2018: 50% tuition refund
- Withdrawal submitted after 15th June 2018: No refund given

Unfortunately we cannot refund tuition if the cancellation is made last-minute.

Cancellation of the course by HFU
